Terms and Conditions

1. **Exclusive Photographer:** Oldsouth Photography shall be the exclusive photographers retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph during the wedding as long as they shall not interfere with the Photographer's duties (specifically flash photography while the Photographer is working) and do not photograph poses arranged by the Photographer.
2. **Retainer and Payment:** The Client shall make a \$200 non-refundable deposit to retain Oldsouth Photography to perform the services specified herein. This deposit shall be applied to reduce the total cost of the package, but is non-refundable. The Client shall pay the remaining balance of the package price 5 days before the service date. The cost of any re-prints or enlargements shall be made at the time of ordering.
3. **Copyright and Reproductions:** Oldsouth Photography shall own the copyright of all images created and shall have the exclusive right to make reproductions whether it is for editorial use, display, or advertisements. Four years after the service date, the Client may, in writing, request a disk of all original images purchased.
4. **Failure to Perform:** If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to the Photographer's illness, then Oldsouth Photography shall return any amount paid to the client but shall have no further liability with respect to this Agreement. This limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Oldsouth Photography. Oldsouth Photography shall not be liable for any amount in excess of the retail value of the Client's package price. Client should be aware that Oldsouth Photography will have on hand backup equipment in event of failure.
5. **Inherent Qualities:** Client has a choice of flash photography during the ceremony or no flash photography during the ceremony. Client understands that if no flash is to be used during the ceremony that high-speed camera settings must be used that may cause a grainy effect in the photograph. Client also understands that flash photography during the ceremony can be distracting. Oldsouth Photography uses very high quality digital cameras with sophisticated computer software to minimize grain in no flash weddings, but due to different lighting in every setting, we do not guarantee no grain photographs. If your setting is very dark (at night with very low light), you might consider flash during ceremony. Please initial below.

Standard Wedding Package \$895

Includes a wedding album with 4 x 6 prints of all photos.
3 hours at Wedding (extra time is at the rate of \$75 per hour)
50 mile travel radius (over 50 miles is \$1 per mile one way mileage)
Includes one 8 x 10 and two 5 x 7 standard photos of your choice.
Password protected web access for 4 months.
All photos burned onto disk, copyright free.
A Bridal Portrait package is available for \$225 extra.
An Engagement package is available for \$200 extra.
A single engagement photo for paper is free at our location.

Deluxe Wedding Package \$1495

Standard Package with these changes: 5 hours coverage, 100 mile radius, Bridal Package, Engagement Package, one 11x14, three 8x10, and five 5x7 standard photos.

Bride's Choice Package \$2495

Deluxe Package with these changes: 6 hours coverage, Mother's album with 60 photos, Leather composite album with 20 pages, one 16x20 canvas photo, two 11x14, five 8x10, five 5x7, and 50 4x6 standard photos.

- 8. Details:** Oldsouth Photography's standard procedure is to take as many photos as possible before the ceremony. We will start portraits an hour and a half before the ceremony with the groom, his groomsmen, and his family members (but not the bride). Then after he is safely put away, for the next half hour we will photograph the bride, her bridesmaids, and her family members (but not the groom). Then after the ceremony, we can complete all photos of bride and groom together, bridal party with bride and groom, and parents with bride and groom in 30 minutes. For couples that do not mind seeing each other before the ceremony, they may decide to take all photographs before the wedding. If so, please allow at least 2 hours time before the ceremony starts and make sure

everyone knows to be there on time. A third option is to do all photography after the ceremony. Make sure guest know there will be a delay of about 1 hour after wedding for photography. Please initial below.
